Consultations between delegations from the Community and the Faroe Islands concerning the fishing licences in 1983 were held on 28 January 1983 in Copenhagen. As a result of this meeting, the arrangements for fishing licences contained in the Council Regulation (EEC) 180/83 Laying down certain interim measures for the conservation and management of fishery resources applicable to vessels registered in the Faroe Islands, need to be amended.

THE COUNCIL OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Economic Community,
Having regard to the Fisheries Agreement between the European Economic

Community, on the one hand, and the Government of Denmark and the local Government of the Faroe Islands, on the other hand (1)

Having regard to Council Regulation (EEC) No. /83 of 25 January 1983 establishing a Community system for the conservation and management of fishery resources (2), and in particular articles 3 and 11 thereof,

Having regard to the proposal from the Commission,

Whereas the Council has adopted a Regulation (EEC) No. 180/83 of 25 January 1983 laying down certain interim measures for the conservation and management of fishery resources applicable to vessels registered in the Faroe Islands (3)

Whereas in accordance with the procedures provided for by the said Fisheries Agreement, consultations have been held on fishery licences for 1983.

Whereas as a result of these consultations the arrangements for fishery licences need to be amended.

HAS ADOPTED THIS REGULATION :

Article 1

Article 3.2. of Regulation (EEC) No. 180/83 is amended as follows:

- 2. The delivery of licences for the purpose of paragraph 1 shall be subject to the condition that the number of licences valid on any one day shall not exceed:
- (a) 14 for fishing mackerel in ICES division VI a) (north of 56°30'N) and ICES divisions VIIc),f), and h), sprat in ICES sub-area IV and division VIa) (north of 56°30'N), horse mackerel in ICES sub-area IV and division VIa) (north of 56°30'N), VIIe),f),h) and herring in ICES division VIa) (north of 56°30'N);
- (b) 12 for fishing Norway pout in ICES sub-area IV and division VIa) (north of 56°30'N) and sandeel in ICES sub-area IV;
- (c) fishing for northern deep-water prawn :
 9 in ICES sub-area XIV,
 5 in NAFO sub-area 1 (south of 56°N);
- (d) 20 for fishing ling and tusk in ICES division VIb). However, the total number of vessels allowed to fish simultaneously shall be limited to 10;
- (e) 14 for fishing blue ling in ICES divisions VIa) (north of 56°30'N) and VIb);
- (f) 3 for fishing Greenland halibut in NAFO sub-area 1 and ICES sub-area XIV;
- (g) 16 for fishing blue whiting in ICES sub-area VII (west of 12°W) and ICES divisions VIa) north of 56°30'N) and VIb);
- (h) 3 for fishing porbeagle in the whole Community zone with the exception of NAFO 3PS;
- (i) 6 for fishing redfish in ICES sub-area XIV.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply until 30 April 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

EXPLANATORY MEMORANDUM

Consultations between delegations from the Community and Sweden concerning the fishing licences in 1983 were held on 27 January 1983 in Stockholm.

As a result of this meeting, the arrangements for fishing licences and catch reporting requirements contained in the Council Regulation (EEC) 179/83 laying down certain interim measures for the conservation and management of fishery resources applicable to vessels flying the flag of Sweden, need to be amended.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Fisheries Agreement between the European Economic Community and Sweden (1),

Having regard to Council Regulation (EEC) /83 of 25 January 1983 establishing a Community system for the conservation and management of fishery resources (2), and in particular Articles 3 and 11 thereof,

Having regard to the proposal of the Commission,

Whereas the Council has adopted a Regulation (EEC) 179/83 of 25 January 1983 laying down certain interim measures for the conservation and management of fishery resources applicable to vessels flying the flag of Sweden (3),

Whereas in accordance with the said Fisheries Agreement, consultations have been held on fishery licences and technical measures for 1983,

Whereas as a result of these consultations the arrangements for fishery licences and technical measures need to be amended.

HAS ADOPTED THIS REGULATION :

Article 1

Article 3.2. of Regulation (EEC) No. 179/83 is amended as follows:

2. Licences shall be issued for the purposes of paragraph 1 subject to the condition that the number of licences valid at any time during a given month shall not exceed:

- 39 for fishing cod and herring in the Baltic Sea,
- 2 for fishing ling in ICES sub-area IV and division VIa) (north of 56°30'N),
- 3 for fishing Norway pout and sandeet in ICES sub-area IV;
- 10 for fishing in ICES sub-area IV all species referred to in Annex 1 other than herring, ling, Norway pout and sandeel.

Article 2

Annex IV, point 1.3. of Regulation (EEC) No. 179/83 is amended as follows:

- 1.3. When fishing for demersal species at weekly intervals, commencing on the seventh day after the vessel first enters the fisheries zone of the Member States and when fishing for herring in the North Sea at three day intervals, commencing on the third day after the vessel first enters the said fishery zone;
 - (a) the information specified under point 1.4. below;
 - (b) the quantity (in kilograms) of each species caught since the previous transmission;
 - (c) the ICES division in which the catches were made.

Article 3

This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities.

It shall apply until 30 April 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
